Since last Fall-2021, the **DJIA has dropped 7,000 points** - **losing 20% of its value**


Netflix was \$687 last Fall and is now trading at \$224 - **losing 67%**

And MOGO Financial was \$6.44 but is now at 91¢ - **down 86%**

If you track Gold and Silver, cryptocurrencies, real estate, oil – you understand these values fluctuate and can fail to hold their value over time. And they may even be worth nothing in the future.


Hop-On Cellular purchased at 15¢ now worth ZERO!



Amazing how much time we spend on Estate Planning –
to handle all our Earthly possessions after our physical body dies.

The federal Estate Tax [“Death tax”] confiscates as much as 40%
of asset values after this Earthly life.

But this morning let’s turn our attention to consider your
extra-temporal INHERITANCE.



This morning I'm here to say that you have been specifically named as a beneficiary to a TRUST - from which you are set to inherit very specific assets.

The best part? Everything included in your inheritance comes without any cost to you.

- No legal fees.
- No intermediary transaction fees.
- No finder's fees.
- No management fees.

And No taxes of any kind. ***Everything has already been paid.***

The first matter involves of your INHERITANCE is confirmation that your full name has been permanently recorded in the Owner's database [which by the way is in the cloud]. It is imperative to have your name entered there, based on each of you at some point in time making an intentional decision to **accept** what the TRUST Owner has already done for you.

Sad to say, many have heard about this offer but have chosen to **NOT accept** this. As such, without that legally-binding status as a recognized heir to the TRUST nothing be apportioned. Remember, this is entirely your personal decision to **accept** being a beneficiary. Inheritance status cannot be based on knowing about it or being friends or family with others who have made the acceptance decision. So first it's all about NAME.

Once your name has been permanently recorded, you may be surprised to find that you are in fact a joint-heir with the Trust OWNER'S Son – such that there is no distinction between all that He inherits from His Father and what you will also inherit. In fact, your status within the TRUST will have been changed so that you are now also legally recognized as a son by the Father. This is to such an extent that He now openly refers to you as “My own beloved child” – which then allows you to not only refer to Him as “Father”, but also with the more informal “Dad”.

The second matter is that I have been tasked this morning to review each of the *PROVISIONS* of your inheritance as they have been demarcated within the Owner's previously transcribed instructions regarding all of these. The transfer transaction from the TRUST'S assets are designated directly to you and have been described as “***unfathomable riches toward you***” [see Ephesians 3:8].

Please be aware there are 2 stages of these Beneficiary PROVISIONS:

Stage-1 is available immediately - right now - no waiting for these.

Stage-2 includes a series of additional riches coming to you at a still future date.

YOUR INHERITANCE

STAGE 1. *Current and Immediate Allocation*

PROVISION 1.0

Your outstanding debt payable as per the wages [see Romans 6:23] due the TRUST Owner has been paid in full and is no longer held to your account. A close “kinsman-relative” has, by his own volition, voluntarily paid your debt so that your updated status has automatically now been permanently recorded [in the cloud] as:

“Nothing Due or Outstanding” any longer

PROVISION 2.0

A down payment has been made as a guarantee towards your still-future full INHERITANCE you are designated to receive. This front-end “*earnest*” clearly shows the sincerity and full intent of the TRUST Owner to follow thru and distribute to you everything promised and provided for in the future.

PROVISION 3.0

The TRUST Owner has guaranteed He will never leave you alone for the balance of your physical life. Based upon PROVISION 2.0 He has the means by which He will always be with you, 24/7, and not forsake you under any circumstances.

STAGE 2. *Future and Expected Allocation*

PROVISION 4.0

In that your current physical body is gradually degrading over time, and will at some point cease to function in this present and temporal Earthly realm, the TRUST Owner has a unique mechanism by which your body will be completely upgraded - such that it will never again degrade or suffer any loss of its design functionality. This will be permanent and come with many additional features and capabilities that are presently unavailable to you in your existing state. Some previews of this enhanced functionality have been previously recorded by eye-witnesses who saw first-hand this new design and functions in the Owner's Son after He previously experienced the death of His physical body.

PROVISION 5.0

The OWNER has an additional mechanism that may in fact precede physical death as referenced in PROVISION 4.0 whereby He will instantly-immediately transfer you out from your mortal-perishable-corruptible body in this temporal realm into an immortal-imperishable incorruptible body outside of this temporal dimension. PROVISION 7.0

Subsection 7.1 *We're saved from **wrath** when He judges sin Romans 5:9*

Subsection 7.2 *We're not destined for **wrath** but for inheritance 1st Thess. 5:9*

PROVISION 8.0

You will personally accompany the OWNER'S Son when He returns to Earth for that wedding reception. After this, the Son will establish His kingdom on Earth for 10 centuries, ruling from the city of Jerusalem, seated on the Kingly throne of His forefather David [who ruled from about 1,000 – 962 BC].

Subsection 8.1 *Having returned with the OWNER'S Son and having been declared a joint-heir with Him in all of His inheritance, you will also have some form of assigned-delegated rule over certain people and location somewhere on Earth within His kingdom hierarchy.*

Subsection 8.2 *When those 100 decades are finished, the OWNER will end the present physical universe and replace it with an even better and amazing NEW heavens, NEW Earth for mankind, and NEW Jerusalem as the city where The OWNER will now permanently dwell among all His son- and daughter-heirs.*

PROVISION 9.0

The OWNER has designated 5 unique “Crowns” to be granted at His discretion. These are referred to with the Greek term **stephanos** that describes a circular wrapped-wreath of leaves awarded to the winner of an event [not the **diadem** crown that is worn by a King as a Royal Ruler]. The 5 award-wreaths include:

9.1 Crown of Righteousness

2nd Tim. 4:8 those who love/look for 2nd Coming of Jesus

9.2 Crown of Life

James 1:12 Revelation 2:10 persevere under trial

9.3 Crown of Glory

1st Peter 5:4 shepherd the flock with love

9.4 Crown of Exultation

1st Thess. 2:19 Philipians 4:1 rejoicing in evangelism

9.5 Incorruptible Crown

1st Corinth. 9:25 imperishable

SUMMARY

Your INHERITANCE is on reserve outside this temporal realm. This is where you store up additional, compounded future value 100% risk-insured against fraud, forgery, theft, or transfers of any kind [see 1st Peter 1:4 it is imperishable - undefiled - will not fade away].

So men, if you list all of your Earthly assets with their values, and then compare those to the 9 Provisions of your INHERITANCE, you'll understand the perspective of **HOW shall we live?** - from the Pharisee Saul from Tarsus:

“for me to live is Christ, and to die is gain” [Philippians 1:21]

Hebrews 12:2 - *“Turn your eyes upon Jesus, look full in His wonderful face, and the things of Earth will grow strangely dim in the light of His glory and grace”*
